As per the reference 5<sup>th</sup> cited and as per statutes on affiliation of Homoeopathic Medical Colleges, Dr. YSR University of Health Sciences, Vijayawada, it is hereby certified that the application of **Maharajah's Institute of Homoeopathic Sciences, Nellimarla, Vizianagaram Dist.**, sponsored by **Sri Rama Educational Trust, Vizianagaram** for running of BHMS Course has been registered with Dr.YSR University of Health Sciences, Vijayawada and **Conditional affiliation** is granted for 4<sup>th</sup> Year **BHMS Course for enhancement of seats from 50 to 100** and for admitting students with an intake of **100 seats ( Hundred seats)** for the Academic Year **2022-23, subject to fulfillment of all the shortfalls pointed out by the National Commission for Homoeopathy.**

The number of students admitted should not exceed the number of students permitted for Annual Admissions both under University and Management Quota as specified by the State Government / Dr. YSR University of Health Sciences, Vijayawada.

The fee collected by whatsoever name called either for university seats or for Management seats shall not exceed the limits specified by the State Government /Dr.YSR University of Health Sciences from time to time.

The Management of the college shall follow the regulations made by the University / State Government in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation in this regard may lead to withdrawal of affiliation to the college without any notice.


