Application for Letter of permission for functioning of Maharajaha Institute of Sub: Homoeopathy Sciences And Hospital, D.No: 31-15, Nellimarla, Near M.D.O. Office, Vizianagaram, Andhra Pradesh-535217 for conducting BHMS course with student intake of 100 seats for the academic year 2023-24- reg.

Sir,

Maharajaha Institute of Homoeopathy Sciences And Hospital, is functional since 2007 and has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 23-24. The College has submitted the Part-1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020.

College is required to follow standard guidelines in the functionality as under:

- a) Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Record Room for academic purpose of students and follow up attendance of patients.
- b) Case sheets should have complete demographic details and contact details of patients.
- c) Diagnosis should be written in ICD 11 criteria

Considering the above observations, and facilities available, Medical Assesment and Rating Board for Homoeopathy has decided to issue permission to Maharajaha Institute of Homoeopathy Sciences And Hospital, D.No: 31-15, Nellimarla, Near M.D.O. Office, Vizianagaram, Andhra Pradesh-535217 for conducting BHMS course with student intake of 100 seats for the academic year 2023-24.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
