Sir/ Madam,

In reference to Medical Assessment and Rating Board for Homoeopathy (MARBH) letter No. 4-7/ MARBH/NCH/2025-26(102-04)/3355, dated: 20.06.2025 Maharajaha Institute of Homoeopathy Sciences and Hospital, D.No: 31-15,, Nellimarla Near M.D.O. office, Nellimarla, Vizianagaram-535217 has filed an appeal to the commission against the decision of MARBH vide their letter no. MIHS/Rep. appeal NCH-25-26, dated: 25.06.2025.

Commission has recommended MARBH vide letter no. 30-5/2025-26/NCH-GR (28)/ 3297, dated: 07.07.2025 for the continuation of permission for 100 seats for 1st BHMS course to the Maharajaha Institute of Homoeopathy Sciences and Hospital, D.No: 31-15,, Nellimarla Near M.D.O. office, Nellimarla, Vizianagaram-535217 for the academic year 2025-26. Accordingly, **MARBH is granting Conditional Permission for 100 seats for BHMS Course for the academic year 2025-26** based on the following conditions:

- i. **College will implement and comply with the X ray unit should be its own along with the establishment of proper functioning of skill laboratory and Medical Education Technology unit within one month failing which permission may be withdrawn for the academic year 2025-26.**

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 100 seats for BHMS course shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried

out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn in the subsequent year if college is found deficient in compliance to MES-2024 anytime during the academic year.
